#### Application Checklist/Requirements

- Completely fill out the entire application – be sure to sign and date
- Provide photos of areas that will be painted as part of the program \*\*\* **Exterior Only**\*\*\*
- Upon completion of the work, contact the Code Compliance Division to arrange a completion inspection

#### Availability of Funds

- The program will be awarded on a first come, first serve basis to applicants meeting all the program guidelines. Up to 10 Gallons of a paint will be awarded per project. The grant recipient shall be responsible for all remaining costs associated with the project. The City of Battle Creek reserves the sole discretion in the review of applications and in awarding funds under this program.

I understand that the presence of any lead based paint and the abatement of such is solely my responsibility. The City of Battle Creek disclaims any liability, warranty or guarantee, related to the presence of lead based paint on the building / structure.

I understand the City of Battle Creek will not be responsible for injuries to any person, including myself, or damages to any personal property.
